#### REPORT OF CHIEF OF STAFF - Karen Zerante

COS Karen Zerante provided a year-end summary on Cartograph, a program used by the City to address issues that were reported to Resident Services. COS Zerante also reported on the Geographic Information System (GIS), a program used by the City to track various information. It was a helpful resource with FEMA grants, such as the \$ 2.5 million dollar drainage plan for the West Side that would address water, sewer and curb issues in the City. She reported that Comcast had provided \$ 10,000 in funds to the City for software updates to the Channel 4 public announcement channel.

Mayor Gonzalez announced that the Department of Housing and Urban Development (HUD), through its Choice Neighborhood Program, had awarded the City a \$ 350,000 grant. The phase one grant would be used in community planning of schools, open space, and commercial areas for the City's East Side Neighborhood.

Police Chief Thomas Rogers reported that the Police Department's "Beards for Kids" Christmas fundraiser had been very successful. Police officers in uniform delivered gifts to needy families, and \$ 3,300 in donations had been raised and would personally be delivered to Shriners Children's Hospital.
