PRESENTATION BY COOK COUNTY COMMISSIONER DONNA MILLER

Commissioner Miller spoke regarding the Invest in Cook Program, an \$ 8.5 million dollar program that covered the costs associated with transportation improvements. She recalled that the program awarded the City \$ 477,900 for Euclid Avenue repairs. In addition, the CDBG program awarded the City \$ 300,000 for street improvements, and \$ 742,000 for Covid-19 mitigation.
